COMMISSIONERS DISCUSSED WITH J. RISK THE SIZE OF THE PIPES AND THE AMOUNT OF FLOW FOR THE NEW CONDO'S AND HOTEL. THE STRSA IS STILL WAITING FOR THE O'DONNELL TO SEND US THE FLOW THAT WAS METERED. MR. NAGURKA (ATTORNEY) ASKED ABOUT THE DISCOUNT THE STRSA GAVE TO M&T ON THE CONDO HOOK-UPS SINCE HE WAS NOT PART OF THOSE MEETINGS BECAUSE AT THE TIME IT WAS A CONFLICT OF INTEREST WITH GILMORE & MONAHAN.

CHAIRMAN COMMISSIONER RUTZLER EXPLAINED THAT THE 40% DISCOUNT ON THE HOOK UP CHARGES FOR THE CONDO'S WERE DONE BEFORE HE WAS CHAIRMAN. CHAIRMAN GLEASON WAS IN CHARGE AND MR. KOSTECKI AND MAYOR CRADLE ASKED FOR A SPECIAL MEETING OF THE STRSA AND AT THIS MEETING MR. MACFADDEN FROM M&T WAS THERE AND ASKED FOR A 40% REDUCTION SAYING THAT IT WAS TO EXPENSIVE FOR ALL THE CONDO'S AT OUR RATE.

### ITEM 5 - O'DONNELL, STANTON

MR NAGURKA ADDRESSED THE COMMISSIONERS ON THE MEETING THAT THE STRSA HAD WITH JACK BERRENS FROM O'DONNELL, STANTON, DAN SEROTTI FROM YEZZI, MIKE NAGURKA (STRSA ATTORNEY) FROM ROTHSTEIN, JONI AND JOHN RISK FOR THE GARAGE AND THE PINELANDS APPLICATION.

MR. NAGURKA STATED THAT THERE ARE CERTAIN THINGS THAT HAVE TO BE DONE FOR THIS APPLICATION AND DAN SEROTTI SAID THAT IT IS BETTER TO PUT EVERYTHING ON THE APPLICATION THAN HAVING THE PINELANDS REJECT IT AND HAVE TO START OVER AGAIN.

MR. NAGURKA ALSO STATED THAT EVERYTHING THAT WILL BE BILLED FROM HIS FIRM AND O'DONNELL, STANTON AND YEZZI WILL COME OUT OF THE CAPITAL BUDGET FOR THE GARAGE.

J. RISK ASKED MR. NAGURKA IF THE STRSA HAS TO SURVEY THE WHOLE PIECE OF PROPERTY INCLUDING THE DPW AND WILL THE BOROUGH BE GIVING THE STRSA ANY MONEY TOWARDS THE ENGINEERING BILL. MR. NAGURKA ANSWERED NO BECAUSE THE STRSA HAS TO INCLUDE THE DPW BECAUSE IT'S ALL ONE PIECE OF PROPERTY AND THE BOROUGH HAS MADE IMPROVEMENTS OVER THE YEARS.

THE COMMISSIONERS AND J. FRAAS DISCUSSED THE STRSA PAYING \$500 A MONTH FOR OUR OFFICE RENT AND \$310 A MONTH FOR A GARAGE RENTAL.

MR. NAGURKA ASKED ABOUT THE VIDEO CAMERAS AND CHAIRMAN RUTZLER SAID IT IS NOW IN THE DETECTIVE'S HANDS. THE STRSA TRIED TO GET THE CAMERA'S BACK WITHOUT GETTING THE POLICE INVOLVED BUT MR. GLEASON FORMER CHAIRMAN OF THE STRSA AND CHAIRMAN COMMISSIONER OF THE REC CENTER HAS NOT RETURNED THE STRSA CAMERA'S.

CHAIRMAN COMMISSIONER RUTZLER INFORMED THE COMMISSIONERS OF AN INCIDENT THAT HAPPENED WITH A CUSTOMER THAT WAS SHUT OFF FOR NOT KEEPING HER PAYMENT ARRANGEMENTS. THE CUSTOMER IS A TENANT NOT THE OWNER SHE WAS VERY NASTY TO DONNA THEN TO JONI AND THEN JONI HANDED CHAIRMAN RUTZLER THE PHONE AND SHE WAS NASTY AND CURSING AND THREATENED TO COME AND PHYSICALLY HURT CHAIRMAN RUTZLER AND THE GIRLS. CHAIRMAN RUTZLER CALLED THE POLICE TO MAKE A REPORT AND SARGENT SCHNEIDT WENT TO THE CUSTOMERS HOUSE TO ADDRESS THE THREATS MADE. CHAIRMAN RUTZLER THEN CALLED THE OWNER OF THE PROPERTY AND TOLD HIM ABOUT THE SHUT OFF AND INCIDENT WITH TENANT. THE OWNER PAID THE BILL AND THE PROPERTY WAS TURNED BACK ON.

COMMISSIONER BRITTON ASKED IF THE STRSA SHOULD SEND A COPY OF THE ARRANGEMENTS MADE WITH TENANTS TO THE PROPERTY OWNER. J. FRAAS SAID NO WE WILL CALL THE OWNER IF THE PROPERTY GETS SHUT OFF AND TENANT DOES NOT PAY TO OPEN IT.
