ON A MOTION BY COMMISSIONER ROLZHAUSEN AND SECONDED BY GRASSO COMMISSIONER TO APPROVE THE MINUTES OF DECEMBER 11, 2019.

ON THE ROLL CALL VOTE ALL COMMISSIONERS VOTED YES, EXCEPT COMMISSIONER BRITTON WHO ABSTAINED.

ON A MOTION BY COMMISSIONER BRITTON AND SECONDED BY COMMISSIONER ROLZHAUSEN TO APPROVE THE BILL LIST INCLUDING PAYROLL IN THE AMOUNT OF \$27,764.44.

ON A MOTION BY COMMISSIONER BRITTON AND SECONDED BY COMMISSIONER ROLZHAUSEN TO ACCEPT THE RESIGNATION OF ANDREW HOWARD.

ON THE ROLL CALL VOTE ALL COMMISSIONERS VOTED YES.

MOTION PASSED.

ITEM 2 – APPOINTMENT OF JOSEPH JUBERT TO THE UNEXPIRED TERM OF ANDREW HOWARD 2/2024.

MR. JOSEPH JUBERT WAS SWORN IN AS ASST. TREASURER FOR THE UNEXPIRED TERM OF ANDREW HOWARD ENDING 2/2024.

ITEM 3 – PINELANDS LETTER

MR. MIKE NAGURKA (ATTORNEY) UPDATED THE COMMISSIONERS ON THE PINELANDS LETTER THAT WAS SENT. MR. NAGURKA THOUGHT THE LETTER WAS MORE POSITIVE THAN THE MEETING WAS. THE BOROUGH WILL HAVE TO ANSWER THE PINELANDS ON CAPPING THE LANDFILL AND THE SUB DIVISION THAT WAS NEVER FINALIZED IN THE 90'S. WE WILL KEEP MOVING FORWARD WITH THE PINELANDS BUT PUTTING A TIME LINE ON CAPPING A LANDFILL HAS NEVER BEEN DONE IN THE HISTORY OF THE PINELANDS.

COMMISSIONER JUBERT SAID THAT THE LANDFILL HAS A HEAVY LAYER OF CEMENT OVER IT AND VERY LITTLE TO NO METHANE GAS.

MR. ROSS ASKED IF THE PINELANDS HAD AN ISSUE WITH THE ADDITION THAT THE BOROUGH PUT ON THE DPW. MR. NAGURKA SAID IT WILL HAVE TO BE ADDRESSED BUT IT WAS NOT THAT BIG OF A DEAL.

COMMISSIONER JUBERT ASKED ABOUT POSSIBLE GRANTS FOR THE BOROUGH TO HELP CLOSE THE LANDFILL. MR ROSS (COUNCILMAN) STATED THAT THE BOROUGH HAD LOOKED INTO GRANTS TO CLOSE THE LANDFILL IN THE PAST BUT COULD NOT FIND ANY.

THE STRSA WILL MOVE FORWARD ON THE REC CENTER GARAGE. THE STRSA COMMISSIONERS AND ATTORNEY WILL SET UP A MEETING WITH THE BOROUGH ADMINISTRATOR, MAYOR, COUNCIL AND REC CENTER COMMISSION.

COMMISSIONER BRITTON ASKED WHAT WE WANTED TO DO WITH THE GARAGE. TAKE THE WHOLE GARAGE OVER? CHAIRMAN RUTZLER SAID YES FIX IT UP AND REPAIR EVERYTHING THAT NEEDS TO BE FIXED AND IT WOULD ONLY BE THE STRSA GARAGE.

MR. ROSS SAID IT WON'T BE A PROBLEM WITH THE STRSA TAKING OVER THE REC CENTER GARAGE FOR SEWERAGE AUTHORITY USE. MR. ROSS SAID ALMOST EVERYTHING IN THE GARAGE NOW THAT BELONGS TO THE REC CENTER IS GARBAGE AND A SINGLE DUMPSTER WOULD PROBABLY CLEAR THE WHOLE GARAGE OUT EXCEPT FOR SOME METAL.

COMMISSIONER GRASSO ASKED IF THIS WILL BE THE STRSA GARAGE WHO WILL HAVE ACCESS. J. FRAAS AND CHAIRMAN RUTZLER SAID THE STRSA OFFICE J. RISK (MAINTENANCE MAN) AND A KEY IN THE LOCK BOX OUTSIDE THE GARAGE FOR POLICE & FIRE.

MR. ROSS STATED THAT BY ORDINANCE THE REC COMMISSIONER IS IN CONTROL OF THE REC CENTER SO THE REC COMMISSIONER MUST HAVE A KEY. THE REC HAS KEYS TO ALL THE RENT SPACE.

COMMISSIONER GRASSO ASKED WHY DOES THE STRSA HAVE TO RENT THE REC CENTER. J. FRAAS STATED BECAUSE WE CAN'T FIND ANYTHING ELSE.

- J. FRAAS ASKED THE COMMISSIONERS ABOUT CUSTOMERS THAT PAY ONLINE AND BOUNCE CHECKS IF WE CAN BLOCK THEIR ACCOUNTS. THE COMMISSIONERS STATED YES BUT THE STRSA MUST SEND THE CUSTOMER AND OWNER A LETTER FIRST.

MR. MIKE NAGURKA (ATTORNEY) STATED THAT MR. JOE KOSTECKI'S LETTER TO THE PINELANDS IS WHAT HE HAD SUGGESTED TO MR. KOSTECKI THAT THE BOROUGH PROPOSE TO USE CLAY TO CAP THE LANDFILL IT WOULD BE CHEAPER.

COMMISSIONER GRASSO ASKED ABOUT THE CLAY AND MR. NAGURKA SAID THE PINELANDS CAN SAY NO TO THE CLAY AND THEN IT WOULD BE VERY EXPENSIVE.

COMMISSIONER JUBERT SAID THE LANDFILL HAS ABOUT 10 TO 12 FEET OF CONCRETE ON IT ALREADY.

CHAIRMAN COMMISSIONER RUTZLER ASKED IF THERE WERE ANY CHANGES TO THE TRMUA SHARED SERVICE AGREEMENT. MR. NAGURKA STATED THAT THEY MADE SOME CHANGES TO THE WAY THEY CHARGE AND ON SOME OF THE RATES.

ITEM 5 – LETTER FROM ROTHSTEIN FOR GARAGE SPACE

CHAIRMAN RUTZLER INFORMED THE COMMISSIONERS THAT THE STRSA HAD A MEETING ABOUT LEASING THE REC CENTER GARAGE JUST FOR THE STRSA USE ONLY. THE MAYOR, MARIA GOLDA, ROB TAYLOR, JOHN RISK, JONI FRAAS, SANDY ROSS, BILL GLEASON, MIKE NAGURKA AND HIMSELF ATTENDED THE MEETING. CHAIRMAN RUTZLER ALSO TOLD THE COMMISSIONERS THAT HE TOLD THE REC COMMISSION THAT THE STRSA WOULD GO NO HIGHER THAN \$150.00 PER MONTH FOR THE GARAGE AND THAT THE STRSA WILL INSTALL A KNOCK BOX FOR THE FIRE DEPARTMENT AND THE REC COMMISSION WILL NOT HAVE A KEY TO THE GARAGE.

COMMISSIONER BRITTON ASKED IF THE ELECTRICAL PANEL FOR THE REC CENTER IS LOCATED IN THE GARAGE AND WHAT PART OF THE BUILDING DOES IT SERVICE? COMMISSIONER BRITTON SAID IF THE PANEL SERVICES ANY OTHER ROOM IN THE REC CENTER THAN THE REC COMMISSIONER WILL NEED A KEY.

CHAIRMAN RUTZLER SAID EVERYONE THAT NEEDS A KEY WILL HAVE ONE WHICH WILL BE JOHN RISK, THE STRSA OFFICE, THE BOROUGH ADMINISTRATOR, HIMSELF (CHAIRMAN) AND ONE IN THE KNOCK BOX.

CHAIRMAN RUTZLER SAID THAT COUNCILMAN MURRAY TOLD HIM THE SPRINKLER SYSTEM FOR THE BASEBALL FIELDS ARE IN THE GARAGE AND HE WOULD NEED TO GET IN THE GARAGE IN THE SPRING AND THE FALL CHAIRMAN RUTZLER TOLD HIM THAT WOULD BE NO PROBLEM.

COMMISSIONERS DISCUSSED WITH J. RISK CHANGING THE GARAGE DOORS. THE GARAGE DOORS AND ANY OTHER WORK TO BE DONE WILL START WHEN ALL THE AGREEMENTS HAVE BEEN SIGNED.

COMMISSIONER JUBERT STATED THAT THE STRSA WILL BE INVESTING A LOT OF MONEY INTO THIS GARAGE AND WE SHOULD NOT BE PAYING \$150.00 A MONTH FOR IT. J. FRAAS STATED THAT AT THE GARAGE MEETING MR. GLEASON REC CENTER CHAIRMAN WAS CONCERNED ABOUT THE MONEY STATING HOW ARE THEY GOING TO PAY FOR SUMMER CAMP. COMMISSIONER JUBERT SAID FUNDRAISERS.

THE EMAIL FROM SANDY ROSS STATED THAT ON WEDNESDAY FEBRUARY 5TH THE REC COMMISSION IS OFFERING THE STRSA A REDUCTION IN RENT FROM \$310.00 PER MONTH TO \$150.00 PER MONTH WITH ADDITIONAL KEYS TO GO TO BORO ADMIN AND POLICE DEPT. ALSO THAT THE GARAGE BE RETURNED TO THE REC COMMISSION AS SOON AS THE STRSA BUILDS ITS OWN GARAGE.

COMMISSIONER JUBERT ASKED IF THE REC CENTER WAS A MUNICIPAL BUILDING? J. FRAAS SAID YES IT IS. COMMISSIONER JUBERT ASKED IF THE REC CENTER PAID SEWER? J. FRAAS SAID NO THEY DON'T. COMMISSIONER JUBERT DOES NOT THINK THE STRSA SHOULD BE PAYING FOR THE USE OF THE GARAGE.

ON A MOTION BY COMMISSIONER BRITTON AND SECONDED BY COMMISSIONER ROLZHAUSEN TO ACCEPT THE REC COMMISSION TERMS.

ON THE ROLL CALL VOTE ALL COMMISSIONERS VOTED YES, EXCEPT COMMISSIONERS JUBERT AND GRASSO WHO VOTED NO.

J. RISK ASK IF THE BOROUGH HALL OR THE DPW PAY FOR SEWER? CHAIRMAN RUTZLER SAID NO THEY DON'T. J. RISK SAID THEN WHY IS THE STRSA PAYING \$500.00 A MONTH FOR RENT.

CHAIRMAN RUTZLER STATED THAT BEACHWOOD MAKES A HIGHER SALARY AND PINE BEACH MAKES A HIGHER SALARY. MARIA GOLDA BORO CLERK SAID PINE BEACH GIRLS ONLY WORK
